PUBLIC COMMENTS: Many topics were discussed

- Disbursement of keys to the compost: A motion was made by V. Jennett and seconded by J. Emry that as of November 15th each year we will collect the keys from those that were issued out a key. The keys will then be reissued out in the spring to those contractors that can provide a listing of the properties of the people they are working for within the township to utilize the compost for disposal.
 - a. Reminded the public that is you have a need to go into the compost on off hours you can also notify us at the township office that you would need a key for the time to just dump your leaves and then retirn the key to the township same day. All members on the board are also willing to assist and open the gate tot eh compost so you can dispose of leaves ONLY.
 - i. Concerns are people will be dumping all other things beside just leaves.

Carole Bleau shared they will be disbursing Christmas Boxes around the Lake in business to collect items for families. The kids party is December 14th at 5:00pm – 7:00pm.

Carole Bleau also shared that she had checked in the concern with placing leaves and debris into the waterways. There is a \$800 to \$5,000 fine that will be issued by the Sheriff's department if caught. Asked if we can get two signed

informing the public that this action is against the law. J. Emry made motion to purchase two signs and seconded by T. Torrey – All approved

Bill McKenzie – shared that as he walks around the lake he is experiencing more fast food wrappers on the ground. Also to be more respectful not to turn your bright lights on people that are walking on the shoulder of the road. Newer cars are automatic and go to bright lights as they don't see lights coming towards them.

Signage for Bike Path and ORV – are here and will wait till spring to install.
